An internal viewing is recommended.

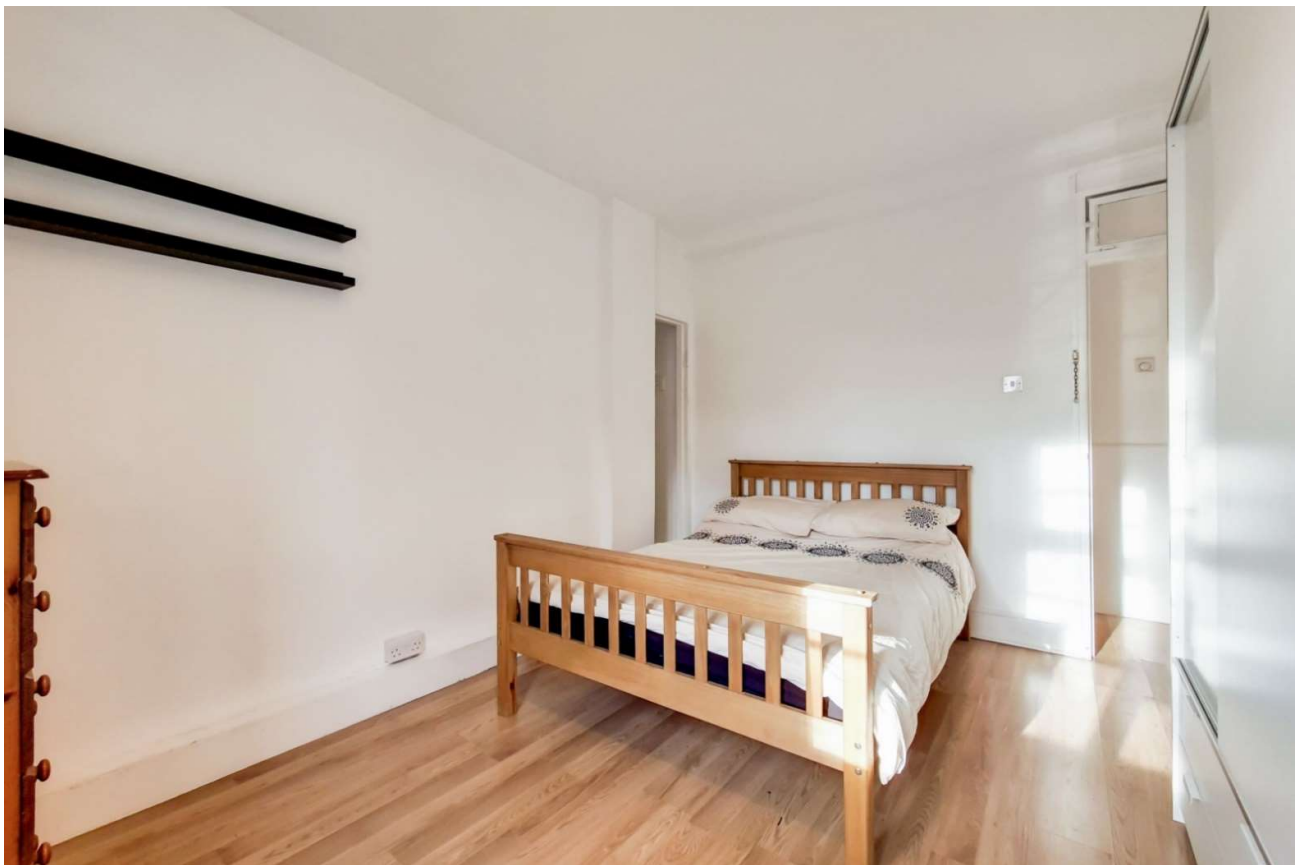

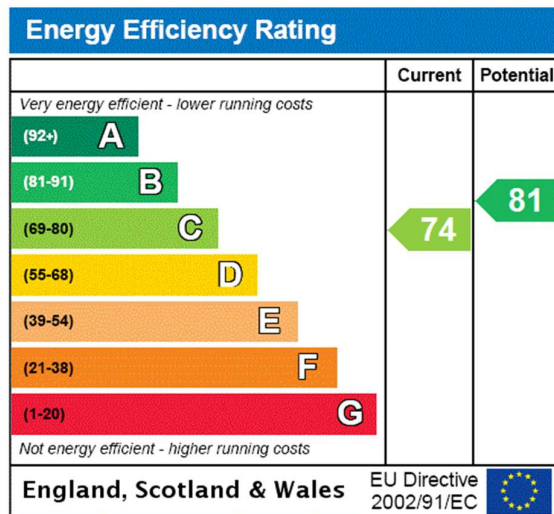


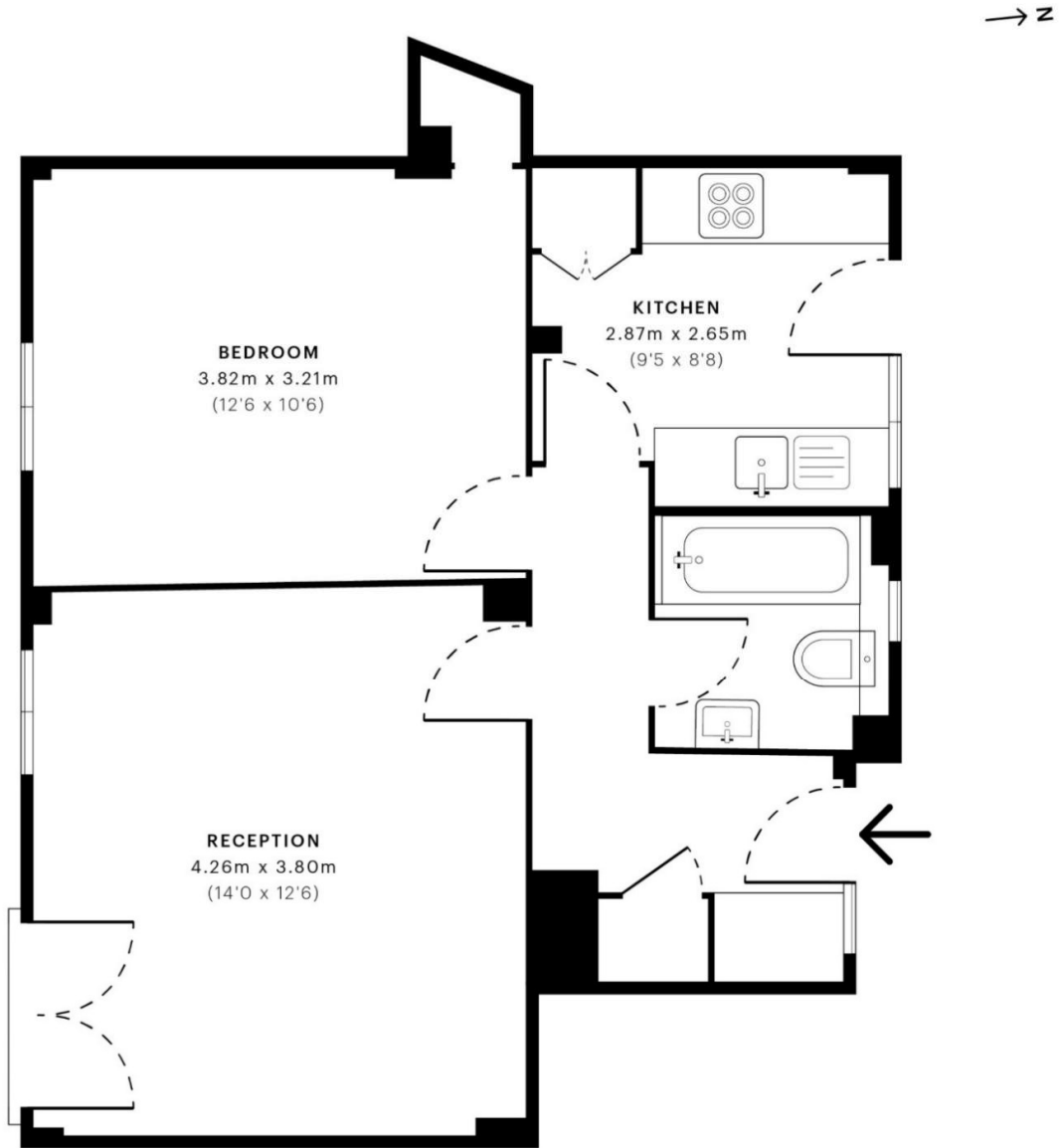
