LOCATION

Melrose House is at the end of Melrose Gardens and forms part of the Melrose Conservation Area. The flat is ideally located for the numerous amenities on offer in Brook Green and Brackenbury Village, which include some fantastic independent shops, including a fishmonger and butcher and a number of excellent pubs and restaurants. 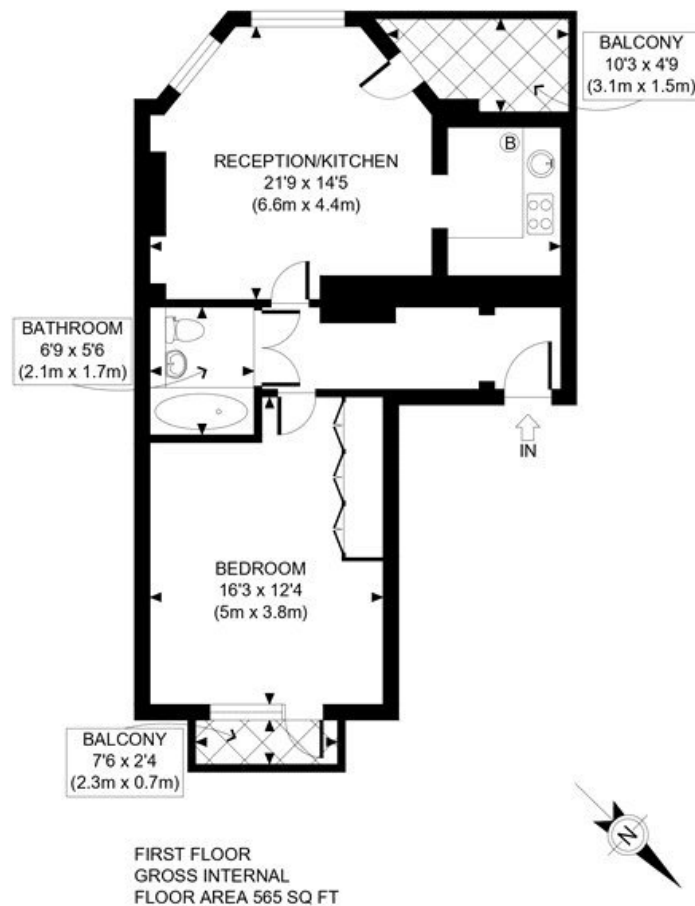
