Penfields House is set close to the junction of York Way with Market Road, nearest tube station being Caledonian Road (Piccadilly line – approx 0.5 miles) and close to local bus services, shops and cafes. The Kings Cross area is a walk away (approx 0.9 miles to the tube station) or a bus ride from York Way for its amenities including Kings Cross rail station, St Pancras Eurostar services, the Regents canal, Granary Square & the shops and restaurants of Coal Drops Yard. The Camden Town area is a bus ride away from Camden Road, for its attractions including Camden Market alongside The Regents Canal.

The flat, which has far reaching views comprises a reception room which has access to the kitchen, a bathroom and a bedroom with fitted wardrobes.

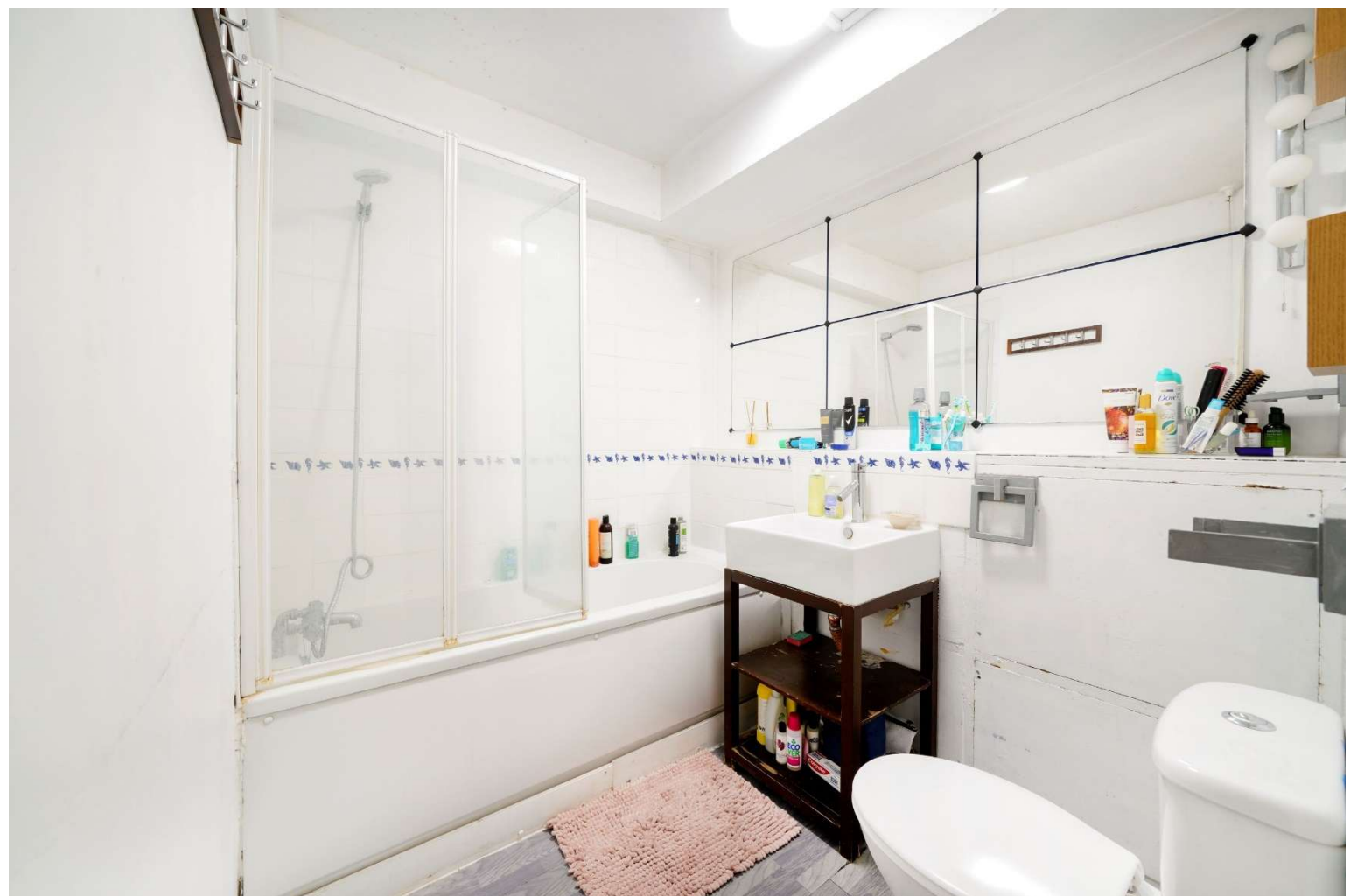

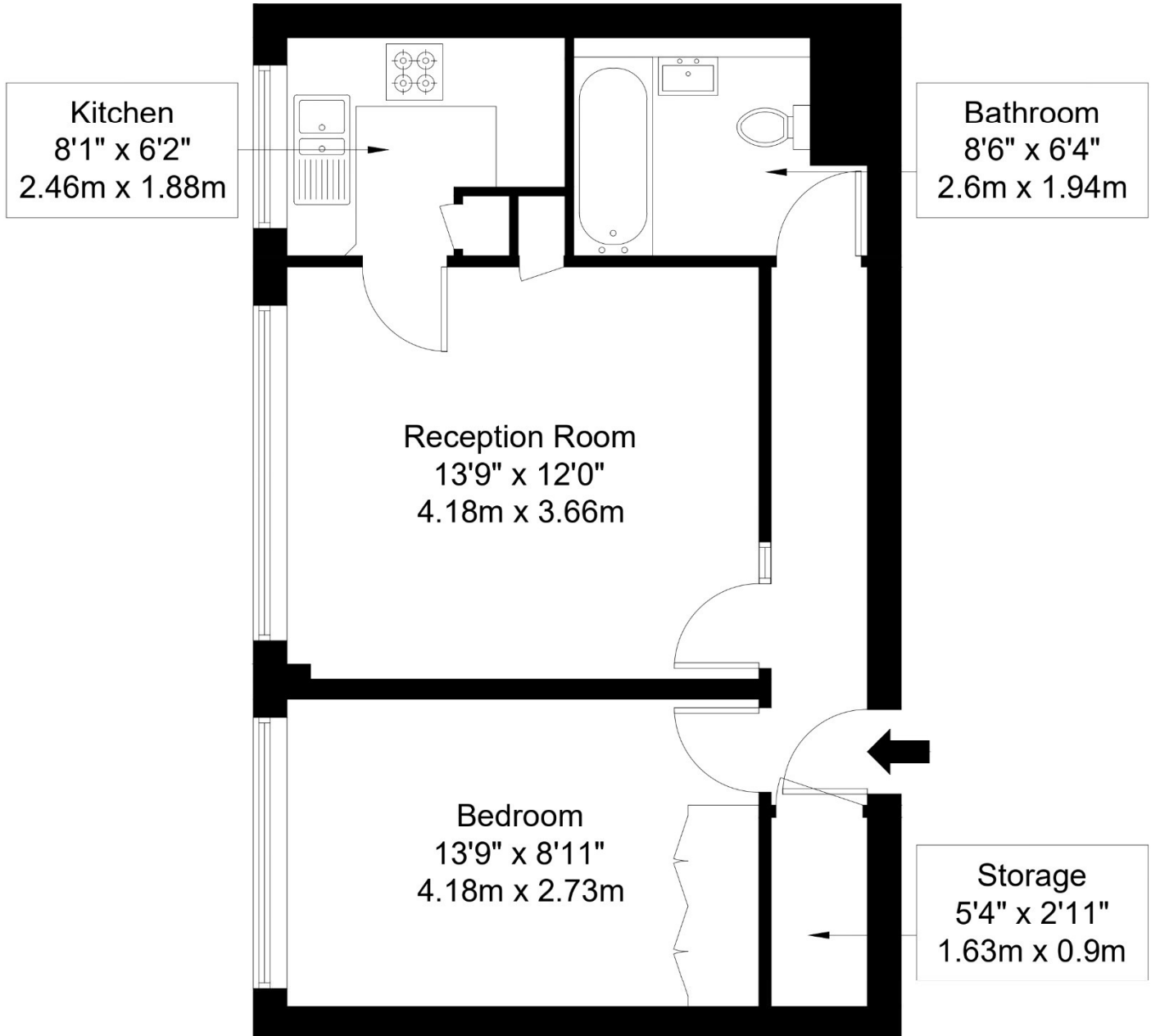
